

DIRECTIONS - RODBELL

I. FROM BALTIMORE (VIA Route 29)

1. Baltimore Beltway to Route 70 west for approximately four miles to south on Route 29 (exit on left).
2. South on Route 29 past Routes 103 and 108.
3. Exit Route 29 on right approx 3/4 mile after Route 108 ("Columbia Town Center").
4. Go approximately 1 mile, and take right fork onto Governor Warfield Parkway
5. Go approximately .25 miles to first traffic light (Windstream Drive); turn right.
6. Stay on Windstream for approximately .25 miles to end at stop sign.
7. Turn right at Green Mountain Circle to third right hand turn
8. Turn right on Catterskill Court to bottom of hill, 10541, - the only two story house at the very bottom of the hill. **(SEE BELOW)**

II FROM WESTERN MARYLAND

1. East on Route 70 to Route 29 south
2. Follow directions beginning with I. 2. above.

III. FROM BALTIMORE (VIA Route 95)

1. South on Route 95 to Route 175 West (Columbia)
2. Stay on Route 175 for approximately 4 miles until it crosses over Route 29
3. Continue on Route 175 past Route 29, and follow directions beginning with I. 4. above.

IV. FROM WASHINGTON (VIA 29)

1. North on Route 29 past Route 32.
2. Exit on right on exit 18. Stay to left to Exit 18B
3. Continue to first left hand turn after third traffic light (Twin Rivers Road)
4. Left on Twin Rivers Road, to first right hand turn after first traffic light (Green Mountain Circle).
5. Right on Green Mountain Circle for slightly more than 1/2 mile to Catterskill Court.
6. Right on Catterskill Court to bottom of hill, 10541- the only two story house at the very bottom of the hill **(SEE BELOW)**

V. FROM WASHINGTON (VIA 95)

1. North on Route 95 to Route 32 West
2. West on Route 32 to Route 29 North
3. North on Route 29 to Exit 18
4. Following directions starting with IV 2. above.

VI. FROM ANNAPOLIS

1. Route. 97 west to Route 32 West

2. Exit Route 32 at Route 29 North
3. Follow directions beginning with IV. 2. above

#### VII. FROM NORTHERN ANNE ARUNDEL COUNTY

1. Take Route 100 West to end
2. Exit on left onto Route 29 South
3. Follow directions beginning with I. 3. Above.

#### VIII. FROM OLNEY/HIGHLAND

1. Take Route 108 East for approximately three miles after Route 32
2. Turn right onto Harpers Farm Road for approximately 1 ½ mile
3. Turn left onto Twin rivers Road for about ½ mile
4. Turn left onto Green Mountain Circle for approximately .6 miles
5. Right on Catterskill Court to bottom of hill, 10541- the only two story house at the very bottom of the hill **(SEE BELOW)**

#### VIII. FROM WESTERN MARYLAND

1. Route 40 or Route 70 East to Rte 29
2. South on Route 29 (exit on right)
3. Follow directions starting with I.2. above.

**For the office walk around car port to steps to lower level. Office entrance is left set of sliding glass doors, at bottom of steps. Please do not block car port.**
